Variety Certification Eligibility APPLICATION (Form 300) to Enter NEW Unregistered Varieties into CSGA Certification,

Attached is a *Variety Certification Eligibility APPLICATION* (Form 300) to enter certain NEW unregistered varieties into CSGA certification.

Amendments to federal Seeds Regulations on April 15, 1997, which exempted corn from official variety registration, also reduced the number of crop kinds (from 50 to 31) that are subject to official variety registration by the Canadian Food Inspection Agency (CFIA) and listed in Schedule III of federal Seeds Regulations. For most varieties of field crops, CSGA has traditionally used variety registration to officially verify the eligibility of new varieties entering the pedigreed crop certification system. Demand for this *APPLICATION* (Form 300) originated with requests to CSGA from the corn industry to continue certifying the varietal identity of seed corn crops even after amendments in 1997 exempted corn from variety registration.

The April '97 Amendments also introduced new exemptions for several "types" of crop kinds. New varieties of these "types" are now entered into certification using this *APPLICATION* (Form 300). Examples of some crops, other than corn, that are exempt from variety registration, include chickpeas, non-"oilseed-type" flax (eg. fibre-types) and soybeans (eg. natto, miso, or tofu), non-"forage-type" alfalfas, fescues, ryegrass and timothy (eg. reclamation or turf-types) and non-"grain-type" lentils, oats or peas (eg. forage-types). This *APPLICATION* (Form 300) is only required once and is usually submitted to CSGA, by a recognized plant breeder, either with or before the first *Application for Crop Inspection* of a new variety:

- of a crop kind exempt from registration or a variety that will not be sold in Canada;
- that has not previously entered official certification in Canada; **and**
- that will require labelling with official seed certification tags.
(ie. This *APPLICATION* (Form 300) is NOT required for experimental strains or breeder lines that will not be issued Foundation, Registered or Certified official pedigreed class crop certificates.)

The *Variety Certification Eligibility APPLICATION* (Form 300) requires a \$300.00 submission fee and does NOT replace the *Application for Crop Inspection* submitted annually to CSGA with field maps and inspection fees before the CSGA's crop inspection *Application Deadline Dates*.

Variety description requirements for this *Variety Certification Eligibility APPLICATION* (Form 300) are similar to the distinguishing characteristics required for variety registration applications. Specific variety description requirements are available for corn, industrial hemp, pulse crops, and soybeans.
